PARTICIPATING SCHOOL (Participants)

1. IMP Note:-No off line entries will be accepted as per CBSE guidelines.

The tournament will be conducted as per the rules and regulations prescribed by CBSE. For details you are requested to visit <u>http://cbsegames.in</u>

- **2.** No team/ player will be permitted to participate unless accompanied by a teacher/ coach designated by the participating school Principal.
- **3.** All expenses on items like travel, food, kit etc. will have to be borne by the participating School.
- 4. The team has to bring mosquito repellent (e.g. All Out, Goodnight), lock and key, torch, soap, toothpaste, own towels and top sheets (a bed sheet & pillow cover for hygiene), any particular medicine required by players with Doctor's Prescription or as per CBSE Norms. The participating teams are not allowed to carry any jewelry, hard cash, weapons or any kind of banned items as per CBSE norms. The school will not be responsible for loss/misplacement of any valuable items or belongings of the team. Responsibility to look after mobiles, cameras, cash and belonging lies solely on the participants only.
- **5.** All the out station teams of boys and girls will be lodged separately. Team who needs accommodation facility must inform on or before **18 July 2025**. Lodging will not be provided to the local teams.
- 6. Each participant / school must remit Rs. 500 per head per day against lodging and boarding .Money will be collected against boarding and lodging on a full day basis and no part payment will be collected and the participating schools will not insist for refund or part payment.
- **7.** The participating teams have to submit Rs. 3000 as security money. It is Refundable only after verification and the money will be refunded after the competition gets over.
- **8.** It is compulsory for out station team staying in the school to have their meals in the school. For local teams, provision of meals will be made on their prior intimation (<u>Coupons for Breakfast</u>, <u>Lunch, Snacks and Dinner once issued will not be taken back</u>).
- **9.** <u>Dining in the mess arranged by the host school is mandatory for the teams that opt to stay in the school provided accommodation</u>. Please note that once your school offer its consent to take a meal in our school cannot be altered later.
- **10.** No outside food and non –vegetarian food is allowed in the host school premises.
- **11.** It is not obligatory on the part of the Organizing School to provide food and transport facility to school/teams making their own stay arrangements. Also, it is the responsibility of the school/teams staying outside, to collect information in regard to matches / fixtures / program etc.
- **12.** Every participant team shall carry with them the required documents as mentioned under title "Eligibility".
- **13.** Every team will carry their school flag, for the purpose of March past and to be used during the various ceremonies. <u>Participation in March past is compulsory, failing to which, their right to participate can be forfeited.</u>
- **14.** Any non designated person accompanying the team will not be entertained for any matter at the venue and will not be permitted to stay in the premises.
- **15.** In case the player/ team is being accompanied only by the parent, in such case, it should be informed by the Principal of the participating school in writing.

ACCREDITED REPRESENTATIVES (TEACHER/COACH/MANAGER)

- **1.** All the teams shall be accompanied by a Teacher/Coach/Manager designated by the participating school Principal.
- 2. No team will be permitted to participate without accompanying officials.
- **3.** No team shall be accompanied by more than two officials.
- **4.** No team shall be accompanied by any parent. However, if a parent is accompanying the team, such information may be provided by the school on the school letterhead.
- **5.** In case of Girls participants, one of the accompanying officials must be a female.
- **6.** The officials accompanying the team shall have a valid Identity Card issued by their school Principal.

Note :- No extra person shall be permitted to stay inside the school premises and on the playfield along with the teams.

<u>ENTRIE</u>S

- **1.** Soon after filling-in the entry proforma, schools shall make travel bookings and send the information to the Organizing school for making the necessary arrangements.
- **2.** In Boy's category, the team shall consist of maximum 4 & minimum 2 players.
- **3.** In Girl's category, the team shall consist of maximum 4 & minimum 2 players.
- 4. <u>Whatsoever the reason may be, on the spot entry and late entry will not be enter</u>tained.

WITHDRAWING SCHOOL

If a school, after filling-in its entry, wishes to withdraw from the tournament/meet, it shall give a written request of its intention to do so, to the Organizing Committee By contacting at :**6260991379 /8827371635/9770971695** Or mail at :<u>kpsisports2@gmail.com</u>

ELIGIBILITY

The participants should be within the particular age group as on 31 December,2025.

- (a) Incomplete information in any respect is liable for disqualification of the team.
- (b) Any violation in eligibility (overage or Impersonation) shall be dealt according to rules.
- (c) Medical check-up may also be applied by the Jury of Appeal, appointed by the Organizing school in the cases of overage suspicion.
- (d) A player shall be under 14, 17 or 19 years of age as on 31.12.2025. Accordingly, for session 2025-26 sports events, the age criteria will be as follows:
 Under 14 years: Born on or after 01.01.2012
 Under 17 years: Born on or after 01.01.2009

Under 19 years: Born on or after 01.01.2007

- (e) All the supporting papers verifying the age of the player etc. in original, as per the CBSE Guidelines and Rules shall be carried personally by the Team Manager/Coach while reporting for participation.
- (f) The player's right to participate forfeits, if fails to produce the papers supporting the eligibility in original, on demand.
- (g) Any participant not fulfilling the eligibility criteria before the commencement of the competition shall not be permitted to participate.

Imp:- Ensure your entry for the Nationals from the Cluster level Organizing School.

IMPORTANT : IT SHALL BE MANDATORY

- (i) To provide the documents for verification in original if asked for.
- (ii) To supply the team photo with the school Principal along with the entry proforma, countersigned by the Principal.
- (iii) For student/player studying in class IX and above, to provide CBSE registration number.
 - (a) All the supporting documents verifying the age of the player in original/attested by the Principal as per the CBSE Guidelines and Rules shall be carried personally by the Team Manager/Coach while reporting for participation: -
 - 1. DOB Certificate
 - 2. Aadhar Card
 - 3. Identity Card of school
 - 4. X Class Pass Certificate (in case of XI and XII Class student)
 - 5. CBSE Registration number (for students studying in IX and above)
 - 6. To supply the eligibility proforma filled-in online, countersigned by the concerned Principal.

ELIGIBILITY/ENTRY PROFORMA:

Every school shall supply the signed copy of the eligibility proforma filled online, to the host school on arrival.

DISQUALIFICATIONS

<u>A player/team may be disqualified for the following reasons</u>:

- 1. If ineligibility of any member of the team is detected.
- 2. Inclusion of non bonafide student in the team.
- 3. Misbehavior on ground by player or accompanying official.
- 4. Use of abusive language by player or accompanying official.
- 5. Misbehavior with Officials/Opponents by player or accompanying official.
- 6. Indiscipline at the place of stay by player or accompanying official.
- 7. Damaging the school property.
- 8. Indiscipline during the Opening and Closing Ceremonies by player or accompanying official.
- 9. Non participation in March Past.

<u>The Organizing school in no case shall show the eligibility proforma or any other paper of a team to anyone who lodges the protest. It is only the jury of appeal's prerogative to verify all the documents.</u>

The Organizing School shall submit details of the defaulters to the Jt Director (Sports) reporting the names of the schools/athletes, in a separate cover. All such defaulters will be debarred from the participation in CBSE Inter School Sports and Games Competition for the next year. If any such school resorts to unfair means again, in the subsequent year, it will be debarred for three years.

PROTEST

Protest of any nature in connection with the tournament shall be in writing and must reach the Organizing Secretary and CBSE Observer within one hour of the declaration of the result, duly accompanied by a fee of **Rs 1000/- (Rupees One Thousand)**.

Such a protest will be considered by Jury of Appeal, consisting of following:-

- 1. Principal, Organizing School
- 2. Organizing Secretary
- 3. CBSE Observer
- 4. One or two technically qualified people present at the venue

The parties under dispute may be heard before deciding the issue. In case the protest is upheld, the protest fee shall be refunded to the protesting school otherwise the fee shall be forfeited.

The decision taken by the Jury of Appeal will be final and binding.

The decision, together with full facts of the protest may immediately be reported to the **<u>It. Director</u>** (Sports)
